

# CCMS Delegation Represents Collier Physicians at FMA Annual Meeting

Collier County Medical Society



CCMS members participating as delegates to the Florida Medical Association represented their colleagues at the 202 FMA Annual Meeting and House of Delegates, August 5-6 in Orlando. The CCMS

delegation consisted of CCMS president and delegation chair Dr. Rebecca Smith, and delegates Dr. George Brinnig, Dr. Alexandra Grace, Dr. Glenn Groat, Dr. Rafael Haciski, Dr. Zubin Pachori, and Dr. Gary Swain, and alternate delegate Dr. Erik Hiester. CCMS members who participated on other delegations included Dr. Jose Baez, Dr. Rebekah Bernard, Dr. Corey Howard, and Dr. Catherine Kowal, and CCMS Alliance Board Member Karen Swain served as the FMA Alliance delegate. During the FMA Annual Meeting, Dr. Haciski was re-elected as a FMA alternate delegate to the to the American Medical Association. Dr. Bernard continues to serve on the FMA Board of Governors, and Dr. Howard continues to chair the AMA delegation.

To help increase the CCMS delegation allotment to the FMA and represent Collier County physicians and patients, CCMS members are encouraged to join the FMA. If every CCMS member joined the FMA, the Society's delegation could double, strengthening our voice at the FMA House of Delegates. Members are also encouraged to contribute to the FMA and CCMS political action committees to help support physician and patient friendly candidates for state and local offices. Visit [ccmsonline.org/membership](http://ccmsonline.org/membership) for a link to the FMA membership information and CCMS PAC dues.

Prior to the meeting, FMA delegates from across the state submitted testimony online on various resolutions and FMA Board of Governors reports proposed to the House of Delegates, and then offered additional testimony at onsite reference committees. Then on Sunday of the Annual Meeting, reference committees presented recommendations that were up for debate by the full House of Delegates. Read on for details of some of the House's noteworthy actions. When the FMA issues a final report, CCMS will share the full report in an upcoming issue of the CCMS e-newsletter.

**Resolution 22-108, Promoting, Supporting Clinical Research**, submitted by CCMS was referred to the FMA Board of Governors for study and report back. The resolution called for FMA support of local physicians who are conducting clinical research and helping them educate the community on the benefits of clinical research.

**Resolution 21-109, Kratom Risk and Safety**, a carry-over from 2021, adopted with substitute language. Support legislative and/or regulatory efforts prohibiting the sale or distribution of Kratom in Florida, while still allowing opportunity for proper scientific research.

**Resolution 22-109, Elder Abuse in Florida**, adopted. Work with the state to improve elder abuse investigations and standardize documentation and referral triggers in EHRs, and the FMA will develop advocacy strategies for further strengthening laws to further protect Florida's elderly.

**Resolution 22-110, Physician Online Ratings**, adopted. Create a training course for physicians that would provide guidance on how to effectively respond to negative online reviews without violating HIPAA guidelines and give physicians tools to address such matters.

**RESOLUTION 22-112, Freedom to Practice Evidence-Based Medicine substitute language/title**, adopted. Oppose any legislation that would create criminal penalties, a civil cause of action, or result in administrative action against the license of a Florida physician when the physician is practicing evidence-based medicine which is consistent with the appropriate specialty society guidelines.

**Resolution 22-208, Prior Authorization and other Advocacy Support of Opinions of the AMA, FMA and County Medical Societies**, adopted as amended. Join other State Medical Societies and the AMA to support and publicize the *Valentini et al v. Group Health Inc.* case about prior authorization by providing an opinion and or by publicly declaring that insurers and their medical directors/other decision makers have duty for care if denying or delaying payments for ordered services, and should be medically liable for downstream consequences of their decisions and for costs to patients and their physicians. Study the outcome of this case report back to members.

**Resolution 22-302, Expanding the Use of Narcan**, adopted as amended. Support legislation that increases use and availability of opioid antagonists, including naloxone in Florida communities, and promotes the development and implementation of opioid antagonists, including naloxone as a community-based intervention to prevent lethal opioid overdose.

**Resolution 22-304, Public Availability of Pregnancy-Related Care**, substitute language adopted. Oppose legislation that would pursue criminal charges against physicians who provide medically appropriate termination of pregnancy, and oppose any future legislation hindering or blocking the availability of FDA-approved treatments for pharmacological termination of pregnancy, regardless of whether used for termination or other unrelated indications, when this is a matter between the physician and patient.

**Resolution 22-308, Employed Physician Non-Compete Contracts**, adopted as amended. Support legislation that non-compete clauses should not be allowed in employed physician contracts when the employing entity is not physician owned and operated and has over 30 employed physicians and the employer has no standard mechanism for future proportional equity partnership within the organization.

**Resolution 22-309, Corporate Practice of Medicine**, substitute language adopted. Support legislation that would ensure that all employed Florida-licensed physicians retain independent medical judgment in providing care to patients, and that employers may not unreasonably interfere with, control, or otherwise direct the professional judgment of an employed physician; and assist employed physicians who have

had the exercise of their professional judgment improperly interfered with by their employer obtain an appropriate remedy.

**Resolution 22-311, Dedicated On-Site Physician Requirement for Emergency Departments**, adopted as amended. Support legislation or regulation requiring that all facilities in the state of Florida that bear the designation of Emergency Department, ED, Emergency Room, ER, or other title, facility logo or design implying provision of emergency medical care must have the real-time, on-site presence of, and supervision of non-physician practitioners, by a licensed physician with training and experience in emergency medical care, 24 hours a day, 7 days a week; and advocate for similar legislation at a federal level with the American Medical Association.

**Resolution 22-314, Opposition to License Free Gun Carry**, substitute language adopted. Support the current requirements to obtain a concealed weapon or firearm license.

**Resolution 22-401, Preventing EHR Refill Errors**, substitute language adopted. Study and report on electronic refill errors which are created by problems with poor EHR functionality and pharmacy business practices; and share the findings of this report with stakeholders whom the FMA deems appropriate in order to effectuate policies that protect patients and physicians from preventable medical errors.

**Resolution 22-402, Formation of Unions**, substitute language adopted. Form a subcommittee to explore and facilitate the formation of unions where appropriate.

**Resolution 22-403, Strategy for Proactive Tort Reform Relief**, adopted. Create a task force with interested stakeholders to review the feasibility of filing legislation that would enact meaningful tort reform including: reinstating caps on non-economic damages; jury notification of settlements reached by other defendants; and a revision of the formula used to extrapolate future medical care that elevates monetary awards.

**Resolution 22-408, Physicians for the Protection of Private Information**, adopted. Make a request to the AMA to make participation in the Data Restriction Program more transparent as well as clarify the “Do not Release Policy” and “The No Contract Status” making them easier to work with and opt out of; and the FMA will educate physicians on the AMA’s Masterfile via an article published through one of their newsletters. This article should include information on how their private information is used and how to opt out of this system via the Data Restriction Program if they are inclined to do so.



## What We Owe Long COVID Patients

When Gov. Andrew Cuomo shut down New York City in March 2020, we knew little about treating COVID-19. While treatment has improved considerably, most dialogue has focused on two types of patients—those with severe, even lethal illness, and those with milder symptoms. Yet there is a third category of patients: those suffering from long COVID, whose symptoms linger for an extended period or mysteriously reappear months after their original infection.



Clinicians recognized the existence of these long COVID patients early in the pandemic. May 13, 2022 marked the two-year anniversary of the opening of the Mount Sinai Center for Post-COVID Care in New York City, a first-of-its-kind unit in the U.S. Since then, long COVID has emerged as one of the biggest but least-addressed medical concerns. Anywhere from 10% to 30%<sup>1</sup> of those who contracted COVID-19 suffer chronic aftereffects, some lasting many months after the initial diagnosis. These patients face increased risk<sup>2</sup> of thromboembolic disease, cardiovascular complications, hepatic and renal impairment, and systemic inflammatory response syndrome.

While most of the U.S. has returned to “normal” (or at least a new version of it), these long COVID sufferers, through no fault of their own, have been left behind. They may have avoided the most serious outcomes of COVID-19 initially but are missing out on the return to life as they knew it. And while these patients struggle, so do their health-care providers—many of whom suffer from long COVID themselves after fighting on the front line as intensive care units and morgues exceeded capacity.

Long COVID presents varying and unpredictable symptoms and has no known cure, so with very little information, health-care providers are facing an uphill battle when it comes to providing adequate care to these patients. The absence of a standard set of interventions leaves caregivers vulnerable to liability risks stemming from misdiagnoses—either by not recognizing that the patient has long COVID or by diagnosing long COVID when, in fact, the patient has another serious disease. Medical errors do happen; in fact, diagnostic error is the No. 1 cause of serious harm,<sup>3</sup> making it the top concern for preventing patient injury. In light of these findings, patients need to present clinicians with the full range of symptoms and ask for comprehensive diagnostic tests to be run in order to identify if it's long COVID or another ailment.

In return, health-care providers need to bring experts from varying fields together. Forming a strong multidisciplinary care team, communicating clearly and often with patients, keeping detailed chart notes, conducting exploratory testing, following up frequently with the patient and proactively referring to specialists are all essential elements of effective long COVID care.

If a patient suspects they suffer from long COVID or presents a variety of symptoms after having COVID-19, their assembled care team—which often starts at the office of their primary care provider—should first rule out a separate underlying illness.

Health-care professionals need to find a balance whereby they maintain, when appropriate, a high index of suspicion for long COVID, without letting long COVID become a catchall diagnosis. Knowing that long COVID can present as more than 200 symptoms<sup>4</sup> affecting 10 organ systems, health-care providers find it challenging to pinpoint which ailments, if any, were a direct result of COVID-19. With so many individual symptoms, patients may see a range of specialists, calling for a high degree of collaboration between providers.


That there are other ailments masquerading as long COVID emphasizes the importance of seeing patients quickly and providing a thorough evaluation. Common long COVID symptoms like chest pain and heart palpitations could also be the presentation of some other, more emergent condition. As frustrating and debilitating as long COVID can be, it can mask worse diseases that might lead to costlier medical bills and a more rapid decline in a patient's health—as well as a higher chance for litigation against physicians if these diagnoses are missed.

When signs of long COVID emerged in the summer of 2020, many doctors were skeptical. Even now—two years later—skeptics remain. Consequently, many patients feel that medical professionals are failing them. In the early 1990s, given limited research, some health-care providers did not yet believe that chronic Lyme was a real disease. Similar doubts have been expressed about long COVID. When health-care providers struggle with doubts about long COVID, they should remember that COVID-19 can result in something other than short-term symptoms or death. There's another scenario—a third category of COVID-19 patients—and we need to accept that reality.




