

Launched in 2013, **The Foundation of Collier County Medical Society** is a 501c3 charitable foundation. The Foundation harnesses the power of medical providers and partners to promote community health programs, health education and outreach, and helps to foster future local medical professionals.

As a Foundation donor, CCMS members, community partners, and supporters can better align their professional and philanthropic commitment to health and maximize the impact to the community.

## As advocates for this mission, the Foundation board of directors is focused on success in four key areas:

- 1 Team with local academic institutions to grow their medical and health care programs and provide need-based scholarships for our future medical professionals
- 2 Fund local programs that provide vital medical services to the underserved
- 3 Provide leadership, advocacy and support for key community health education programs
- 4 Ensure professional oversight and responsible stewardship of donor contributions

## Foundation Scholarships:

The Foundation of CCMS offers two scholarships: the **Dr. William and Nancy Lascheid Memorial Scholarship for Medical Students**, recognizing future physicians who demonstrate excellence in community service; and the **Foundation Healthcare Scholarships**, for students enrolled or accepted into healthcare degree programs. Awards are given based on need and academic performance.

The Foundation awarded six scholarships in 2025, for a total of \$37,500. The Foundation has awarded over a quarter of a million dollars in scholarships since 2013.

# Physician Wellness Program



The CCMS **Physician Wellness Program** (PWP) was created by Collier County Medical Society in 2017. The Society's goal is to build funds to operate this vital program in perpetuity. Supporters can help CCMS sustain the PWP and the health and well-being of our physicians, which in turn will help them care for their patients. ## How the Wellness Program Helps Physicians

From difficulties with the healthcare system and work/life balance, to traumatic events, litigation, and difficult patients or colleagues, whatever the issue, PWP services provide a safe harbor to address normal life difficulties and the challenges of a medical career, receive coaching on managing stress and trauma, and reclaim satisfaction in your career and personal life.

CCMS provides **up to 6 complimentary sessions** with a psychologist per year as a benefit to CCMS members, whether active, retired, adjunct, associate, or resident physician. New applicants will also be eligible; non-members can visit our membership page for information on joining. CCMS contracts with **independent, doctorate-level clinical psychologists** who have been evaluated by the volunteer CCMS Physician Wellness Committee members.\*

**Confidential appointments are self-referred and physician-initiated** with no medical diagnoses, no insurance billing, and no electronic records. No member identification or notification are ever provided to employers, CCMS, or board of medicine. Identities are never disclosed to others without written consent. Participating psychologists bill CCMS directly with de-identified data.

Contributions to the Physician Wellness Program can be made by electing to restrict your donation to the program on the Partner Commitment Form (found in this file) or by including the name of the program in the memo line on your check.

*\*Although CCMS has vetted the contracting therapists for general suitability, basic qualifications, and Florida licensure to provide services, we do not independently verify their credentials nor do we guarantee their suitability for any particular issue for which a CCMS member may seek therapy.
