A Message from the CCMS President

CCMS took the opportunity to join with many of our county society colleagues from across the state to visit with our legislators at the Capitol in Tallahassee during the second legislative committee week of December. Our goals were to improve physician collaboration with our elected officials at the state level and discuss some of the most critical issues in healthcare legislation.

I was joined by CCMS Past President and FMA Treasurer, Dr. Rebekah Bernard, and CCMS Executive Director April Donahue as we kicked off our visit on the evening of Monday, December 8th with a multi-county reception. Physician delegations from Duval, Broward, and Miami-Dade Counties and Central Florida hosted several legislators for a casual meet and greet. It was a pleasant opportunity to connect with those who serve us at the Capitol and get to know them a bit better.

On Tuesday, in addition to a little time spent enjoying the history of the Capitol Building, the three of us met with Representatives Yvette Benarroch and Lauren Melo. Among the issues discussed were human oversight of AI determinations in health insurance claims, retroactive claims denials, caps on non-economic damages in wrongful death legislation, and scope of practice expansion. Learn more about these issues on page 6 of this magazine. We also discussed pending legislation from Rep. Benarroch regarding full licensure options for physicians trained in Puerto Rico, with participation in the conversation via phone from CCMS Past Presidents Dr. Rolando Rivera and Dr. Catherine Kowal.

Late that afternoon, a new omnibus bill was filed in the House, HB 693 also known as the "Florida Big Beautiful Healthcare Frontier Bill." This large piece of legislation has expansions of authority for non-physician members of the healthcare team that are concerning for their potential impacts on patient safety. On Wednesday, our executive director April, along with Dr. Kowal and her colleague Dr. Bob Levine from the

Florida Society of Rheumatology, had the opportunity to meet with Senator Kathleen Passidomo and added this proposed legislation to their discussion.

CCMS will work with our colleagues throughout Florida and our partners in the legislature to ensure our patients, family, friends, and communities are protected while championing ways to safely increase access to care.

We thank Representatives Benarroch and Melo and Senator Passidomo for their time listening to our concerns and providing their insights, and we look forward to continuing to work with them throughout the session. Note that this is Senator Passidomo's last session in the Florida Senate, as she terms out this year. CCMS is grateful for her many efforts over the years to protect the physician-patient relationship and work with the medical community to provide access to quality healthcare in our state.

The continued engagement and dedication you, our CCMS members, bring to our mission makes our advocacy efforts possible. We're thrilled to see our membership continue to grow, welcoming over 90 new members in 2025, including the new residents and fellows from our local GME program at NCH. That brings us to a total of over 790 members, with over 640 actively practicing members! We enjoyed meeting many of these new members at the CCMS New Members Welcome Reception on November 21st at the Naples Grande Beach Resort, a delightful evening with nearly 200 in attendance.

If you haven't yet renewed your membership for 2026, please do so soon to continue receiving full access to our member benefits, including our physician wellness program, networking opportunities, and advocacy updates. I would be remiss to not include a shout-out and well-deserved kudos to the many physicians and healthcare professionals who planned, hosted, and performed in the Physicians' Community Talent Show on November 16th at the Sudgen Theater in Naples. How it Works

- Use a session to help with your mental wellness self-assessment; make your new year’s resolutions stick; receive tips on time management & communication skills; address lawsuits/disciplinary action; or simply talk.
- To participate: call the psychologists’ private, CCMS member **appointment line, 239-208-3984**. Receive a same-day response during business hours or next-morning response after hours.
- See one of the psychologists within 72 hours to 1 week, possibly sooner for urgent needs, with telehealth and evening or early morning hours potentially available. You may extend your check-up for up to 5 more cost-free sessions.

2026 State Legislative Update

CCMS and Medical Society Partners

Each year, medical societies and associations across the state identify legislative priorities that will be the hot button concerns in healthcare for Florida. The issues listed below are among those that we believe will capture the bulk of advocacy efforts for the 2026 legislative session. As the session is a continually developing process, unforeseen issues might arise. We will collaborate with our partners at the Florida Medical Association, county medical societies, and specialty medical societies, to address these concerns with our legislators to ensure that the only legislation that passes will honor the physician-patient relationship and protect the health and safety of our community.

Put Physicians, not Machines, in the Driver's Seat

Supporting legislation that would prevent machines from making decisions that negatively impact patients and require “qualified human professional” review for any automated system denial or adjustment of care. Currently, artificial intelligence (AI) can be used to deny care that a patient needs. The legislation would require a human to sign off on any such denials and take responsibility for denying care that a doctor has deemed medically necessary. It would end the practice of AI, machine learning algorithms, or automated systems from making treatment decisions on whether a patient receives the care that has been prescribed for them as medically necessary.

Payment Certainty to Benefit Patients & Physicians

Supporting legislation that aims to prevent health plans from retracting their determination for covered services after care has been provided, except under specific circumstances. This law already exists to protect dental practices and should include physicians. Currently, if a physician has received prior authorization from a health plan to perform procedures covered under the patient's plan, the health plan can still deny payment for the claim after it is submitted and retroactively claw back payment from the physician. This denial interferes with the doctor-patient relationship and shifts the burden of unexpected payment to the patient.

Prevent Skyrocketing Medical Malpractice Premiums

Advocating that meaningful, medical malpractices caps be included in repeal of the exception in current Florida wrongful death law allowing for a decedent's adult children to recover non-economic damages (“pain and suffering”) if there is no surviving spouse; and the parents of an adult decedent if there is no surviving spouse or surviving minor or adult children. The legislation in its current form does not cap the amount that can be awarded – allowing the expanded pool of survivors to recover unlimited non-economic damages in wrongful death medical liability suits. Adding caps on damages and attorney fees would ensure a more equitable medical liability framework that protects Florida's provider community and the patients we serve.

Maintain High Quality and Lower Costs for Patients

Opposing scope of practice expansions for non-physician practitioners beyond the highest level of their competency. Non-physician practitioners are critically important members of quality team-based care that promotes patient safety and shared medical decision making. The opportunity to escalate unexpected complications when moments matter is critically important for patient safety. Research indicates that non-physician practitioners are often more expensive given an overreliance on diagnostic imaging and referral to specialists. Previous legislation that enabled autonomous primary care for APRNs has not increased access to care or resulted in increased APRN licensure in Florida.

CCMS Legislative Advocacy: Serving our Members and their Patients

CCMS is constantly focusing on major areas of concern to our physician members while monitoring the political and business climate. Advocacy is one of our core values, and our efforts locally, statewide, and nationally address critical issues on behalf of physicians and patients.

CCMS sends a delegation to the FMA House of Delegates each year where FMA policy is formed and a strong legislative agenda is created. We meet with our legislators to advocate for members and their patients and provide important commentary and information to the press. The CCMS Political Action Committee (PAC) supports the campaigns of physician & patient-friendly candidates at local and state levels with contributions from our members and their spouses.

CCMS members may join the CCMS Legislative Committee to assist with our advocacy efforts, and CCMS members and spouses are encouraged to contribute to the CCMS PAC. Call CCMS at 239-435-7727 or email april@ccmsonline.org for details.

What is the CCMS PAC?

To pass laws that protect patients and support the medical profession, physicians need strong allies among local and state elected officials. The CCMS Political Action Committee was created to help elect candidates to local and state offices who are aligned with CCMS healthcare advocacy policies. The CCMS PAC can donate to political campaigns, while CCMS itself cannot.

The CCMS PAC solicits voluntary contributions from physicians, their spouses, medical students, and resident physicians to research, interview, and support the election of medicine-friendly candidates.

Is the CCMS PAC non-partisan?

Yes. The CCMS PAC can support pro-medicine candidates of any political parties. The CCMS PAC works closely with CCMS physician members and medical societies from around the state to identify pro-medicine candidates as they seek elected office.

Who can contribute to the CCMS PAC?

Anyone who wishes to support medicine-friendly candidates, including physicians, their spouses, medical students, and resident physicians can support the PAC. The suggested contribution is \$100 annually. Contribute at ccmsonline.org/membership/#dues (note: PAC Contributions are not tax deductible).

When you contribute to the CCMS PAC, you help make Collier County and Florida a better place to practice medicine by helping pro-medicine candidates get elected. Your dollars help ensure that physicians have a voice in government, which is vital in passing pro-medicine legislation and defeating harmful bills.

Purchasing or Leasing Healthcare Real Estate – Key Determining Factors

One of the most common questions physicians ask is: Should I purchase or lease my office space? While many assume that owning their home means they should also own their office, the truth is that the best choice depends on multiple factors. There is no universal answer—each practice must evaluate its specific needs, finances, and long-term plans before deciding.

Leasing Your Office Space

Flexibility:

Leasing typically offers greater mobility. With a 5-, 7-, or 10-year lease, you can relocate or renew at the end of the term without the work involved in selling a property. This makes leasing attractive for newer practices or those anticipating future changes.

Concessions:

Landlords often offer strong incentives to healthcare tenants—especially when the tenant is professionally represented. These concessions may include tenant improvement allowances, free build-out periods, and even free rent after opening. With proper negotiation, these benefits can reach well into six figures, reducing upfront costs and borrowing needs.

Availability:

In many markets—especially dense urban areas—leasing options significantly outnumber purchase opportunities. In some regions, properties for lease outnumber those for sale by 10 to 1 or more. Because of this, providers should evaluate both leasing and purchasing options to determine what best fits their operational needs.

A thorough lease-versus-purchase analysis should include monthly costs, principal paydown, tax impacts, landlord concessions, and long-term equity position at 10-, 15-, and 20-year intervals. This full comparison ensures an informed decision.

Purchasing Your Office Space

Additional Asset:

If you have the required down payment, can secure financing, and have viable properties available, purchasing can be a powerful long-term investment. Many physicians find their real estate is worth as much—or more—than their practice at retirement.

Retirement Income:

Physicians can also sell their practice while keeping their building

and leasing it to the buyer. This creates an annuity-like income stream, often with a property that is already paid off.

Healthcare-Specific Financing:

Working with healthcare-focused lenders can be advantageous. These lenders understand build-out timelines, specialized space requirements, and the financial strength of medical practices, often resulting in more favorable loan structures.

Principal Paydown & Equity:

Ownership allows you to build equity over time. After 10–15 years, property equity can easily reach into the hundreds of thousands or more. Once the mortgage is paid, costs are generally limited to upkeep, taxes, and operating expenses—a major long-term financial benefit.

Tax Benefits:

Both leasing and buying offer tax advantages, but ownership adds depreciation and mortgage interest deductions. A CPA and experienced agent can help you understand how these apply to your situation.

Additional Considerations

Your decision should also reflect where you are in your career.

- **Start-ups:** Leasing is often ideal for the first 7–10 years as you learn your market, space needs, and patient volume.

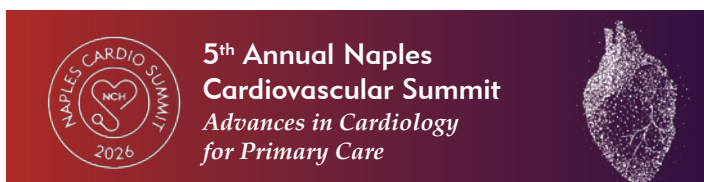

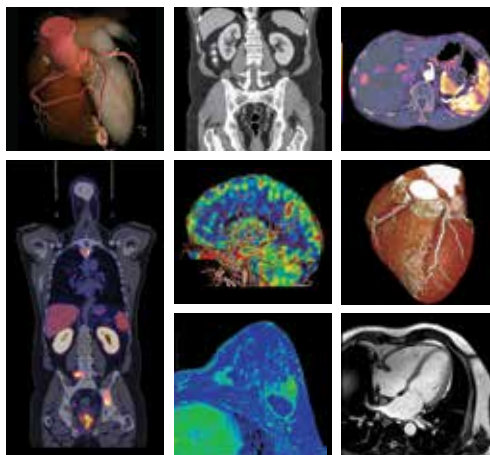

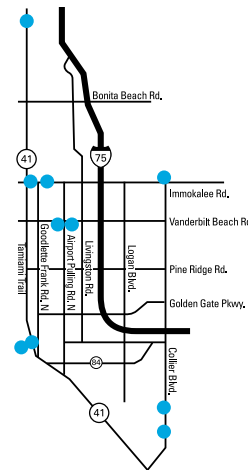
